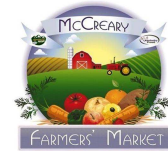

Tentative plans include opening the market for 2016 on Saturday May 7th with hours of operation including each Saturday from 9:00am until sold out. We are also looking again at doing some "mobile markets" at various locations and some Thursday evening markets throughout the season.

We are also planning for some special events at our markets this year with the full schedule to be finalized and released as we move toward spring.

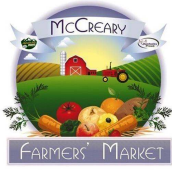
Our market would love to have you involved this year as a vendor and member. We have adopted some new membership options as outlined on the membership application. These include regular membership which is still \$40.00 for the entire year; senior citizens membership for those age 65 and older at a discounted rate of \$20.00; a youth/student discounted membership for \$20.00 which is open to anyone high school age or younger; and a family membership. The family membership starts with the regular \$40.00 membership fee with an additional \$10.00 fee for families desiring an additional setup table/space at the market. This is ideal for a family that may include a primary vendor and spouse or children that will need additional space to sell their own items.

As a member at any level, you are entitled to a space and table at each farmers' market setup we do throughout the season.
