WHEREAS; The McCreary County Solid Waste Management Area is governed by the McCreary County Fiscal Court; and,



WHEREAS; A Public Comment period on the McCreary Solid Waste Management Plan 2013-2017 Update was conducted in the County,



McCreary County Solid Waste Management Plan Update 2013-2017

The McCreary County Fiscal Court, in conjunction with the McCreary County Solid Waste (109) Advisory Board proposes to adopt the county's Solid Waste Management Plan update per 401 KAR 49:011, Section 5. The plan, if approved, will serve as the basis for handling solid waste management issues in McCreary County for the years 2013-2017.

The proposed plan is available for public inspection beginning Wednesday, August 1, 2012 at the following locations during their normal business hours:

- McCreary County Judge-Executive's Office, 1 North Main Street, Whitley City, KY
- McCreary County Public Library, 6 North Main Street, Whitley City, KY
- McCreary Solid Waste Office, 57 Caterpillar Lane, Stearns, KY 42647

Additional information about this plan is available from Linda Babb, McCreary County Solid Waste Coordinator at (606) 376-2556. Anyone unable to review the plan at the above locations may call and request that a copy be mailed to them.

Any person wishing to comment on the plan may do so by providing comments no later than close of business on Friday, August 31 to the McCreary County Fiscal Court at PO Box 579, Whitley City, KY 42653. Any person wishing to be heard at a public hearing must make a request via telephone, fax, email or written communication to the governing body identified above not late than close of business on August 31.

A public hearing is scheduled for Monday, September 10, 2012 at 4 p.m. to receive public comments on the plan. The hearing will be held at the McCreary County Courthouse. However, if no request for a public hearing has been received by August 31, the hearing may not be held.

The Fiscal Court will respond to written public comments within 15 days of the close of the public comment period (August 31). The plan will be considered by the Fiscal Court for passage during regular session on September 10. The plan, if approved, will then be submitted to the Kentucky Energy and Environment Cabinet for review and approval.

ANY PERSON WISHING TO COMMENT ON THE PLAN MAY DO SO BY PROVIDING COMMENTS NO LATER THAN CLOSE OF BUSINESS ON FRIDAY, AUGUST 31 TO THE MCCREARY COUNTY FISCAL COURT AT PO BOX 579, WHITLEY CITY, KY 42653. ANY PERSON WISHING TO BE HEARD AT A PUBLIC HEARING MUST MAKE A REQUEST VIA TELEPHONE, FAX, EMAIL OR WRITTEN COMMUNICATION TO THE GOVERNING BODY IDENTIFIED ABOVE NOT LATE THAN CLOSE OF BUSINESS ON AUGUST 31.

A PUBLIC HEARING IS SCHEDULED FOR MONDAY, SEPTEMBER 10, 2012 AT 4 P.M. TO RECEIVE PUBLIC COMMENTS ON THE PLAN. THE HEARING WILL BE HELD AT THE MCCREARY COUNTY COURTHOUSE. HOWEVER, IF NO REQUEST FOR A PUBLIC HEARING HAS BEEN RECEIVED BY AUGUST 31, THE HEARING MAY NOT BE HELD.

THE FISCAL COURT WILL RESPOND TO WRITTEN PUBLIC COMMENTS WITHIN 15 DAYS OF THE CLOSE OF THE PUBLIC COMMENT PERIOD (AUGUST 31). THE PLAN WILL BE CONSIDERED BY THE FISCAL COURT FOR PASSAGE DURING REGULAR SESSION ON SEPTEMBER 10. THE PLAN, IF APPROVED, WILL THEN BE SUBMITTED TO THE KENTUCKY ENERGY AND ENVIRONMENT CABINET FOR REVIEW AND APPROVAL.
